- Made a new line in document for font fund, placed \$25 to start, suggest placing \$25/mo in fund
- Attendee commentary
  - Paypal has programs for nonprofits to decrease fees which we should look into
  - suggestion to consider fundraising
  - can OSPA paypal acct be used to collect separately for meetings to avoid people using personal accounts? discussion deferred
- Web Administrator - Since the last report, the website had 641 unique users and 1,440 site sessions.
  - 79% were new visitors, and 21% were returning.
  - Visitors came from 43 countries.
  - 58% were direct (not from a link, social media, or search engine); 22% came through Google, 15% found OSPA via Wikipedia, and the remaining 5% through other search engines and links on other websites.
  - 65% came from mobile devices, 34% from Desktop, and 1% were on tablets.
  - We had one form submission directly from the website to OSPA support.
  - Most visited pages were Meetings, Homepage, and Literature.
  - There was a new meeting posted - the Saturday OSPA and Neurodivergency Meeting at 11:30 AM EST.
  - The WSO meeting link was also updated to reflect the motion to return to its own Zoom account.
  - The web administrator added language to the meeting page explaining that the schedule is a rotating calendar after feedback that is not obvious and creates confusion when fellows do not see the WSO meeting listing.
  - Attendee commentary: has anyone looked to see whether OSPA has a wikipedia page?
    - Emily K added some information to [the wikipedia page on excoriation disorder](#) under the treatment heading
    - question of alignment with traditions to associate OSPA with the concept of "treatment"
    - OSPA does not have its own wikipedia page
    - need to have a registered account on wikipedia and have already contributed to a certain number of articles
    - consider coordinating with Social Media Account Moderator on this
- Tax & Legal Committee:

- taxes and annual corporation docs in FL were filed on time, nothing to do until next year
- **Email Support:** representative not present
- **Social Media Account Moderator:**
  - all social media accounts paused
  - continuing to research how social media accounts would work with the traditions
  - hasn't found any social media that are WSO run from other 12 step programs, only affiliated or "friends of"
- **Chip Representatives:**
  - No chips sent out this month due to pause re: unlicensed font.
  - We're bringing a motion about existing chips; will outline below
- **Literature Committee:**
  - 2-3 literature items nearly ready to go but no guidelines for how OSPA approves literature
  - intention to make the approval process as inclusive of a broad representation of the fellowship as possible rather than an incidental small number of attendees at one meeting
    - suggestion: lit committee approval, then present officers at WSO
    - google form for meeting reps to vote for approval or not
    - quorum
  - 2026 committee will start meeting monthly, will request to use the OSPA Recovery Zoom account
  - plan to create a literature committee email
  - Daily reader to send editable version to literature committee, secretary will coordinate
  - Current pdf for daily ready has old OSPA logo on it, caution to ask meetings not to use this image

#### 4. Unfinished Business

- **Motion:** WSO Treasurer to create a spending plan for trademark application filings for the following: wordmark “Obsessive Skin Pickers Anonymous,” wordmark “OSPA,” design mark “OSPA full logo,” and design mark “O icon.”
  - **Intent:** Without a trademark, any person or organization could use the same name, acronym, or logo. This would lead to confusion about unofficial or third-party content. Registering OSPA’s name and logo helps make it clear that the website, literature, recovery chips, and other materials come from OSPA. Most 12-step fellowships have taken this action to support clarity and continuity in their message.
  - Motion seconded, discussion:
    - we have 4 items to trademark and we can do them in order of importance as recommended by intellectual property attorney consults
    - this is another thing that should be done or in motion before literature is approved
    - if this motion is approved, Treasurer and Tax and Legal will get together to create a plan and return with a motion or report for spending and moving forward with trademarking
  - Motion **amended** to: WSO Treasurer, Tax and Legal Committee, and Literature Committee to discuss a spending plan for trademark application filings for the following: wordmark “Obsessive Skin Pickers Anonymous,” wordmark “OSPA,” design mark “OSPA full logo,” and design mark “O icon.” These groups will return with a motion or report for spending and moving forward with trademarking.
  - Amended motion **passes** 7 yea, 1 abstain

## 5. New Business

- **Motion** to set aside \$25/mo for font fund until Oct 2028 at which point the fund will be revisited and WSO will decide what to do with money.
  - Oct 2028 marks the three year period after which legal action cannot be taken for use of the unlicensed font
  - Cathryn/treasurer will report back if this rate is no longer sustainable
  - motion **passes** 7 yea, 1 abstain
- **Motion:** I (Emily) move that the chip representatives destroy all chips containing the unlicensed font.
  - disclaimer: chip reps will explore alternative solutions for chips in the future, this is not the end of the use of chips at OSPA
  - “destroy” means throw away
  - original graphic designer Julie is willing to redesign chips
  - Motion **passes** 7 yea, 1 abstain
