- a. In the current OSPA preamble it writes: "OSPA welcomes those with the related disorders of Trichotillomania (hair pulling), and self-mutilation disorders". <u>Motion:</u> Change to "OSPA welcomes those with the related disorder of Trichotillomania (hair-pulling) and other body-focused repetitive behaviors, such as nail biting, lip or cheek biting, and nose-picking."
 - Mera motion, Cathryn seconded
 - What is the goal for changing the wording?
 - Goal is to remove "self-mutilation disorders"
 - What about leaving it with "and other body-focused repetitive behaviors"?
 - Are we welcoming self mutilators to the program? Cathryn's understanding is that we are welcoming self mutilators as a related disorder in this program for recovery
 - Some think they are related, many of us have both and get recovery here for both
 - Important is the term "related" since trich and self mutilation are related disorders if not skin picking themselves
 - Personal opinion cutting can fit into picking and/or self mutilation
 - Greg not in favor of the motion
 - The name is Obsessive Skin Pickers Anonymous, being more specific is more problematic.
 - Nina motion to keep this in unfinished business and discuss again
 - Amy prefer to just eliminate the sentence "OSPA welcomes those with related disorders..."

- Looking at the 3rd tradition and the steps it says "desire to stop skin picking"... the important distinction is the individual's definition.
- Molly more comfortable with making the sentence more simple per Greg's suggestion
- Mera Amend the Motion: Remove the sentence that says "OSPA welcomes those with the related disorders of Trichotillomania (hair pulling), and self-mutilation disorders".
