Website statistics (August 3rd to September 6th)

- Since the last report, the website had 749 unique users and 1,740 site sessions.
- 77% were new visitors and 23% were returning.
- Visitors came from 44 countries.
- 63% were direct (not from a link, social media, or search engine);19% came through Google, 13% found OSPA via Wikipedia, and the remaining 5% through other search engines and links on other websites.
- 69% came from mobile devices, 29% from Desktop, and 2% were on tablets.
- We had five form submissions from the website to OSPA support.
- Most visited pages were meetings, homepage, and literature.
- There was a correction to the WSO meeting time posted, and updates to the Monday Recovery Behavior and Friday Easy Does It meetings.

5. New Business

- <u>Motion</u>: to maintain, rescind, or amend the motion that WSO adopted at the May meeting which temporarily changed the WSO meeting duration and location.
 - This motion was originally made with a plan to revisit it in August. Was not discussed in August.
 - Original wording: "Motion to shorten the WSO meeting to 45 mins starting June 2025, to delay elections until June, and to use (pending approval) the Sunday Meeting's Zoom account to begin the WSO meeting 15 minutes after the end of the Sunday Meeting. WSO would pay the Sunday Meeting proportionately for use of their Zoom account, ¼ of the monthly cost of maintaining the account. This setup has an experimental period of 3 months, to be discussed again at the August 2025 WSO meeting."
 - o 2 components to address
 - the shortening of the meeting from 60 to 45 minutes
 - the use the Sunday meeting's Zoom room and proportional payment of ¼ of the monthly cost
 - Previous motion <u>rescinded</u>. OSPA meeting will return to original time, length and Zoom link starting October WSO meeting
- Motion: WSO to set up a monthly fund, should it be needed, for the next three years.
 - Intent: The retired font requires a license fee of \$1000-\$1500 to continue using. After OSPA officially retires the font in all materials, there will be a three-year waiting period for the font owner to request retroactive license payment. During this time, OSPA can save this money gradually and, if decided, donate it as amends at the end of three years. (Note: The open Instagram account is included in "all materials" so until it is deactivated, the three-year period doesn't start.)
